Location: Fremont Family YMCA. Fremont, Nebraska. 1558 E. Military St. 68025

Register: See attached mail in form. Make sure you enter your athlete information accurately (especially birthdate). On the form, fill in the blanks with desired event and accurate entry time per event. (Example: Event 6 Women's 50 Free – 38.90). Enter "NT" if you do not have a time. You may mail in your entries and payment beforehand. Payment will be accepted the day of the meet.

Facility: Dillon Family Aquatics Center in Fremont, Nebraska. Pool is a total of 12 lanes SCY x 6 lanes LCM. The meet will be swum SCY, 8 lanes will be used for competition. Colorado Timing System with automated touch pads at the start end only, electronic button timers for back up. Lane Zero and lane eleven on the outside of the pool will be open for warm up/cool down.

Time: Check-in begins at 9am. Deck entries close firmly at 9:30am. First warm-up is 9:30am – 10:20am. Meet Starts at 10:30am.

Eligibility: US Masters Recognized meet. Do not need to be a registered Masters swimmer to participate. Must be registered Masters for times to qualify for Masters State/National Records.

Rules: The current USMS rules will govern the conduct of the meet. Heats will be seeded, slowest to fastest. Please enter a goal time for accurate seeding. Entries with no times will be seeded in the slowest heats. Results will be broken out by age group and gender (i.e. Men/Women, 19-24, 25-29, 30-34, 35-39 etc.).

NOTE: Your age for this meet is your age on 12/12/2021.

Awards: Ribbons for places 1-6th. Results will be split into these age groups by Male and Female : (18-24), (25-29), (30-34), (35-39), (40-44), (45-49), (50-54), (55-59), (60-64), (65-69), (70-74), (75-79), (80-84), (85-89).

Entry Fees: \$30 Early Entry fee. You can swim up to a Maximum of 6 events total, relays included. Deck entries for up to 6 events the day of the meet = \$40. Please pay with Cash or Check ONLY, no card.

Deadline: Register by e-mail to davids@fremontfamilyymca.org by midnight Monday December 6th, 2021 for the early entry fee. Late and deck entries will be accepted at the meet by 9:30am at the \$60 rate. Payment due when you walk into the meet.

Limits: Swimmers may swim up to maximum six events including relays. Please be aware that this meet will run fast. If you enter back-to-back events, your rest time will be very short (or nonexistent).
